Smith County Farm Bureau Scholarship

It is a goal and priority of the Smith County Farm Bureau (SCFB) to make available scholarships for Smith County youth that have positively contributed to the agricultural industry or who plans and/or has attributes to positively influence the agriculture industry.

Smith County Farm Bureau (SCFB) shall award annual scholarship(s) for the purpose of supplementing higher education expenses.

Submission Deadline: Smith County Farm Bureau office located at 12208 Hwy 31 W, Tyler on or before 5 pm, March 31, 2023.

Smith County Farm Bureau will announce scholarship(s) recipients on or before April 30, 2023.

A maximum amount of a \$1,500 scholarship can be awarded to each recipient.

Applicants are encouraged to reapply for annual scholarships until the applicant no longer meets and satisfies applicant requirements listed below.

Applicant Requirements

- Smith County Farm Bureau Member or family member of a Smith County Farm Bureau Member
- High School Senior or High School Graduate currently enrolled in a higher education or technical institution
- Not older than 22 years as of June 30

Applicant Preferences

Applicants are <u>strongly preferred</u> and <u>suggested</u> to have participated or attended the following activities to maximize scholarship funds awarded to the recipient. If an applicant has not participated or attended the following activities <u>does not</u> exclude he or she from being considered or awarded a scholarship:

- Youth Leadership Conference
- Submitted Farm Bureau District 5 Scholarship Application
- Participated in the Free Enterprise Speech Contest

Scholarship funds are disbursed to recipient(s) on or before September 30, 2023. Any funds not requested and/or claimed by September 30th are considered unclaimed and abandoned thus will not be disbursed. Applicants must provide proof of enrollment in a higher education institution to the Smith County Farm Bureau Office on or before September 30th. Verification/proof of enrollment is a paid tuition receipt.

Guidelines & Procedures

Smith County Farm Bureau shall award on an annual basis zero (0) or as many scholarships annually that does not exceed the current years budgeted amount. The Smith County Farm Bureau Scholarship Committee has discretion to award each recipient an amount not to exceed a maximum (\$1,500) per applicant per year per scholarship.

Suggested priority and parameters of selecting recipient(s) and scholarship amounts to award are as follows:

- 1. State and District Participation: Attendance & Completion of Leadership Conference
- 2. SCFB Participation / Volunteer: Ag Field Days; Planet Agriculture
- 3. Participation of Free Speech and/or other State Farm Bureau Contest
- 4. Submission of Farm Bureau District 5 Scholarship & TXFB Scholarships
- 5. Farm Bureau member prior to Jan 1 of the current year; number years of SCFB member
- 6. Future plans of agriculture involvement /advocacy
- 7. Grades
- 8. Family Finance Needs
